Apply with sprayer or wipe on with cloth or sponge. Removes soap scum, lime deposits, grease, grime, rust, discoloration, mineral deposits such as calcium (hard water deposits) and other types of soils. Use on stainless steel, copper, brass, aluminum, concrete, ceramic tile, porcelain, stone, brick, fiberglass, grout.

For use in bathrooms, kitchens, restroom facilities in schools, industrial facilities, public venues, hotels, motels, sporting arenas. Use on toilets, urinals, tubs, showers, doors, sinks, hoods, and countertops.

DIRECTIONS FOR USE: Spray on surface or apply with damp sponge or cloth. Allow product to set and work prior to wiping off, 3–5 minutes, depending on the amount of soil. Heavy deposits may require light scrubbing with a brush. Rinse thoroughly with clean water or wipe with a clean damp sponge or cloth. Pre-testing on a hidden area of surface is recommended. Not for use on marble or chrome.
