

Eliminates or prevents most blockages in air conditioning drain lines due to build-up of biofilm, rust, scale, sludge, air-borne dust, silt and other solids.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. When used as directed FAB-TABS will inhibit the growth of odor causing bacteria and combat stale water odors and keep drain pans clean preventing condensate pan overflow due to drain line blockage. For up to 30 gallons of water; start treatment by dropping 1 tablet into humidifier reservoir; evaporative cooler reservoir; or drain pan of air conditioner. Apply 1 additional tablet every 3 months or whenever odors occur. Treatment may be more effective if drain pan or reservoir is emptied and cleaned before each tablet application.

FIRST AID

Have the product container or label with you when calling a poison control center or doctor; or going for treatment.
